

2007 PAYMENT ORDER OF ENTITLEMENTS FORM

REQUEST TO CHANGE THE ORDER OF PAYMENT OF DIFFERENT VALUE ENTITLEMENTS IN RESPECT OF THE 2007 SINGLE PAYMENT SCHEME (SPS)

Most applicants under the Single Payment Scheme have only Standard entitlements, or Standard and Set-aside entitlements. **If this is your situation, there is no need for you to return this form.** Payment will be made based on the number of eligible hectares declared on your 2007 SPS application form.

However, some applicants under the Single Payment Scheme have different types of entitlements. For example, you may have National Reserve entitlements (as a result of Consolidation or a direct allocation from the National Reserve) and also have Transferred Standard entitlements (as a result of acquiring additional entitlements by way of a lease etc).

Where all entitlements are not used in 2007 because you do not have one eligible hectare of land for each entitlement, payment will be made in the following order:

Firstly: Set-aside entitlements, where applicable, take priority over all other Single Payment entitlements.

Secondly: Entitlements that come in full from the National Reserve.

Thereafter, Standard, Transferred Standard entitlements or topped-up National Reserve entitlements commencing with the highest value entitlements.

Where an applicant holds "SPECIAL CONDITION" entitlements only, these will be paid separately.

You may wish to choose a different Order of Payment by completing the form overleaf. Enter your preferred Order of Payment in Column 6 by, inserting 1 in Column 6 against the entitlements to be paid first, inserting 2 in Column 6 against the entitlements to be paid second and so on.

You should however note the following:

- **Entitlements allocated in full from the National Reserve must be claimed each year for 5 years otherwise they will be returned immediately to the National Reserve.**
- **Where entitlements have been topped-up by more than 20% from the National Reserve, only the top-up element, granted from the Reserve, will be returned to the Reserve.**
- **2007 is the final year for using entitlements that were not used in either 2005 or 2006; otherwise they too will revert to the National Reserve. You may therefore use this form to apply for entitlements in 2007 that were not used in 2005 or 2006. Ensure that you sign and date this form and return it with your 2007 SPS form or to the address below, on or before 4 May 2007.**
