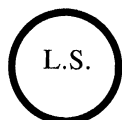

REGULATIONS 2007

I, MARY COUGHLAN, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive No. 2006/127/EC of 7 December 2006<sup>1</sup>, hereby make the following regulations—

1. These Regulations may be cited as the European Communities (Minimum Conditions for Examining of Vegetable Species) (Amendment) Regulations 2007.

2. The European Communities (Minimum Conditions for Examining of Vegetable Species) Regulations 2004 (S.I. No. 121 of 2004) are amended in Regulation 2 by substituting for the definition of “Directive”, the following—

“ ‘Directive’ means Commission Directive 2003/91/EC of 6 October 2003<sup>2</sup> and Commission Directive 2006/127/EC of 7 December 2006”.
