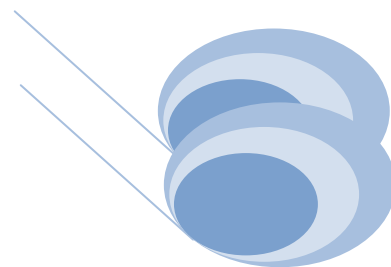

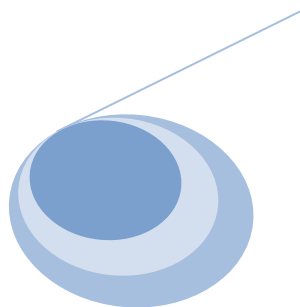

**Please note the following:**

- In order to be authorised to hold a Meat Feeder Authorisation, the applicant must comply with the European Communities (Animal By-Products) Regulations 2014 (S.I. No. 187 of 2014) and in accordance with Regulation (EC) No. 1069/2009 and Regulation (EU) No. 142/2011.
- **Please note:** The application form must be completed by the ‘operator’. The operator is defined as ‘the natural or legal persons having an animal by-product or derived product under their actual control, including carriers, traders and users’.
- The completed application form and supporting documentation should be sent to: Department of Agriculture Food and the Marine, Milk and Meat Hygiene/ABP/TSE Division (MFL), Grattan House, Grattan Business Centre, Dublin Road, Portlaoise, Co Laois.
- *Applications that are incomplete, that contain insufficient or unsatisfactory information or that do not comply with conditions or legislative requirements will be returned to the applicant and a revised, fully completed application must be re-submitted.*
