### **European Communities (Registration of Importers of Animal Products) (Amendment) Regulations 2004**

1. These Regulations may be cited as the European Communities (Registration of Importers of Animal Products) (Amendment) Regulations 2004.
2. The European Communities (Registration of Importers of Animal Products) Regulations 2004 (S.I No. 269 of 2004) are amended by-
  - a) Substituting “Regulation 5” for “Regulation 4” in Regulations 7(1), 7(2), 8(1) 8(2) and 8(3) in each place where occurs.

## **EXPLANATORY NOTE**

*(This note is not part of the instrument and does not purport to be a legal interpretation.)*

This Order amends S.I No 269 of 2004, which provides that for the import of animal products the importer and importing agent must be registered.
