European Communities (Pesticide Residues) (Foodstuffs of Animal Origin) (Amendment) Regulations 2004

Commission Directive 2003/118/EC of 5 December 2003²⁸ hereby make the following Regulations-

1. (1) These Regulations may be cited as the European Communities (Pesticide Residues) (Foodstuffs of Animal Origin) (Amendment) Regulations 2004.

(2) These Regulations come into operation on 4 June 2004 in relation to 24-DB, pendimethalin and oxasulfuron and on 1 December 2004 in relation to acephate and parathion-methyl.
2. The European Communities (Pesticide Residues)(Foodstuffs of Animal Origin) Regulations 1999 (S.I. No. 180 of 1999) is amended in Regulation 2 (1) by substituting for the definition “Directive” the following -
