**European Communities (Pesticide Residues) (Cereals)  
(Amendment) Regulations 2005**

1. These Regulations may be cited as the European Communities (Pesticide Residues) (Cereals) (Amendment) Regulations 2005.
2. The European Communities (Pesticide Residues)(Cereals) Regulations 1999 (S.I. No.181 of 1999) is amended in Regulation 2(1) by substituting for the definition of "Directive" the following –

Explanatory Note

*(This note is not part of the Instrument and does not purport to be a legal interpretation)*

These Regulations amend regulations on the fixing of maximum residue levels for pesticides in and on cereals by adding maximum pesticide residue levels for isoxaflutole, trifloxystrobin, carfentrazone-ethyl, mecoprop, mecoprop-p, maleic hydrazide and fenamidone as shown in Annex I of Commission Directive 2005/37/EC to Annex II Part A of Commission Directive 86/362/EEC and replacing the maximum pesticide residue levels for propyzamide in Annex II Part A of Commission Directive 86/362/EEC with those shown in Annex II of Commission Directive 2005/37/EC .
