Fisheries Management Notice No. 62 of 2013

(November Celtic Sea Herring Quota Management Notice)

I, Simon Coveney, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by section 12 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea Fisheries, Foreshore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), hereby issue the following Notice:

1.1 This Notice is November Celtic Sea Herring Quota Management Notice 2013 (Fisheries Management Notice No. 62 of 2013).

1.2 This Notice comes into force on 1 November 2013 and ceases to have effect on 1 December 2013.

2. In this Notice:

“CECAF” means the Committee for the Eastern Central Atlantic Fisheries;

“EU waters” means European Union waters. Where this term is used in conjunction with an ICES or CECAF sub-area or division listed in Schedule 1. It means that only the European Union waters of that sub-area or division are included;

“length” means, in relation to a sea-fishing boat, the overall length of the boat or the distance from the forepart of the stem of the boat to the aft side of the head of the sternpost of the boat or to the foreside of the rudder stock;

“celtic sea herring authorisation” means an authorisation to fish for Herring (*Chupea harengus*) in ICES areas VIIg, VIIh, VIIj and VIIk, (HER/7G-K) granted under section 13 of the Sea-Fisheries and Maritime Jurisdiction Act 2006;

‘Catch retention and landing restrictions’ means the total quantity, in tonnes live weight, of that species of fish in column (1) a quantity of which, greater than that specified in column (3), may not be retained onboard or landed by an Irish sea-fishing boat, during November 2013.

“fishing area” means waters falling within the ICES and CECAF sub-areas and divisions listed in Schedule 1 as defined in Regulation (EEC) No. 3880/91 of 17 December 1991¹ or Council Regulation (EC) 2597/95 of 23 November 1995², as amended.

3. A person on board an Irish sea-fishing boat less than 20 metres in length to which a Celtic Sea Herring authorisation has not been granted, **fishing for Herring by means of gillnets** in a fishing area listed in column (2) of Schedule (1) shall not have or retain on board or land (or cause or permit another person to have or retain on board or land), during November 2013 a quantity of Herring that is greater than the quantity specified in column (3) of Schedule (1) if the fish was caught in that fishing area during November 2013. **Advance notice of landings**, for vessels not reporting by electronic means (ERS) quantities of Herring over 250kg must be hailed to the **Irish Fisheries Monitoring Centre** by telephone 00 353 21 4378752, by fax 00 353 21 4378096 or by email to fmcireland@defenceforces.ie

4. A person on board an Irish sea-fishing boat less than 20 metres in length to which a Celtic Sea Herring authorisation has not been granted, **fishing for Herring by means of trawls** in

a fishing area listed in column (2) of Schedule (2) shall not have or retain on board or land (or cause or permit another person to have or retain on board or land), during November 2013 a quantity of Herring that is greater than the quantity specified in column (3) of schedule (2) if the fish was caught in that fishing area during November 2013. **Advance notice of landings**, for vessels not reporting by electronic means (ERS) quantities of Herring over 250kg must be hailed to the **Irish Fisheries Monitoring Centre** by telephone 00 353 21 4378752, by fax 00 353 21 4378096 or by email to fmcireland@defenceforces.ie

This Notice sets restrictions on the catching, retaining on board or landing of Herring in ICES areas VIIg, VIIh, VIIj and VIIk, (HER/7G-K), by under 20 metre boats without a Celtic Sea Herring Authorisation fishing by means of gillnets and trawls during November 2013.
